All Dibrom® Concentrate and Trumpet® EC drums are HDPE, non PFAs, and DOT classified as hazardous. Failure to meet recycling requirements for any portion of the pick-up order will result in the return of all affected drums, subsequent disposal fees, and potential DOT fines. We ask that you prepare accordingly, communicate thoroughly, and be patient.

Confirm the following before requesting pick-up from Container Services Network (CSN):

- O Each drum weighs 29 lbs. or less and all openings are tightly sealed.
- Each pallet includes four drums, securely wrapped to the pallet.
- All pallets are staged for clear access by the carrier's truck.
- Your loading dock, forklift/pallet jack are available for loading.
- You are prepared to load the trailer with no driver assistance.
- Prep a minimum of eight drums to return.24-32 is an ideal quantity for LTL pick-up.
- Allow 7-21 days for carrier pick -up, depending on your location and time of year.
- Provide your hours of gate access with a mobile number for your person on-site.

- Expect an email within the same or next business day from a CSN representative with anticipated details for your load.
- Your BOL will be emailed to you the day before the shipment is to be picked up.
- When received, carefully review your BOL for accuracy and driver pertinent notes.
